#### ITEM 6.3 Affordable Housing Forum Update

#### **RECOMMENDATION:**

That SSROC Delegates:

### Purpose of the report:

To provide an update to Delegates on the Affordable Housing Forum held on 24 July 2017 that was organised by SSROC in partnership with the Planning Institute Australia and in collaboration with Community Housing Providers.

#### Background:

During council workshops on strategic priorities for the Central and the South District Plans, and at the SSROC Housing, Strategy and Advocacy Session earlier in 2016, affordable housing was identified as a key priority. The General Managers Forum approved the establishment of an Affordable Housing Working Group (AHWG) and granted approval for the group to proceed with a proposed Affordable Housing Forum in October 2016.

The AHWG led the Affordable Housing Forum, in partnership with the Planning Institute Australia and in collaboration with leading Community Housing Providers (CHPs).

#### **Current Status:**

#### The Affordable Housing Forum

- The Affordable Housing Forum took place on Monday, 24 July 2017 at the Aerial Function Centre, University of Technology Sydney, from 8.30am to 4.30pm.
- The Hon Anthony Roberts MP, Minister for Housing, Minister for Planning and Special Minister of State was the Special Guest and represented the NSW Premier.
- A total of 198 people registered for the forum and 182 attended. Council officers from across metropolitan Sydney, NSW and interstate attended.
- Keynote and sessional speakers from local government, state agency, development industry, community housing sector, and urban development and housing professionals and experts participated. Among the speakers were: the Social Commissioner, Greater Sydney Commission, Heather Nesbitt; the CEO of Urban Development Institute Australia, a peak development industry body, Steven Mann; Acting CEO of Urban Growth NSW, Steve Driscoll; Director Urban Renewal, Department of Planning and Environment, Ann-Maree Carruthers; and the Principal, SGS Economics and Planning, Dr Marcus Spiller.
- SSROC President, Cr Sally Betts, some General Managers and Councillors attended the forum. The President used her opening speech to highlight SSROC's affordable housing position to the Minister.
- A pre-event video was played during the SSROC President's speech. Which can be viewed at:

- A brief (5 minutes) advocacy video will be produced following the forum.
- Six organisations sponsored the forum, five CHPs and one local council.
- The sponsorships are \$19,000 in total. SSROC expects \$12,000 profit share after reconciling costs with the Planning Institute Australia, our partner for the forum.

#### **Forum Outcomes**

• A forum communique will be sent to the NSW Government, the Greater Sydney

- Commission and other key players in housing policy and strategy. A draft is attached and a copy of the final version will be sent to SSROC Delegates and GMs out of session (Attachment A).
- The participation of all sectors, and the presence of the Hon Anthony Roberts MP who is looking forward to the outcome of the forum and made a commitment to consider the recommendations of the forum participants, is expected to complement and strengthen SSROC's advocacy positions on affordable housing.
- The forum and collaboration enabled SSROC to broaden its engagement with stakeholders in furthering advocacy for policy, strategy and delivery solutions to affordable housing.
- Following up on some of the key issues progressed projects such as Housing SEPPs and affordable housing in Central and South Districts.
- Evaluation of of the forum has been overwhelmingly positive.

#### What Next?

- 1. The Affordable Housing Forum communique to Hon Anthony Roberts MP and relevant key agencies.
- 2. AHWG will consider possible housing advocacy priorities following the forum.

## Communique from the Affordable Housing Forum held at the University of Technology Sydney

The Affordable Housing Forum organised by the Southern Sydney Regional Organisation of Councils (SSROC) and the Planning Institute Australia in collaboration with the NSW Federation of Housing Associations was held on Monday, 24 July, 2017.

Following the Forum that was attended by presenters and participants from the State and Local Government sectors, the development industry, community housing providers, non-government organisations, research and planning, housing and urban development professionals and consultants, the Communique below were issued.

#### **NEED FOR AFFORDABLE HOUSING**

#### Quantum gap and market failure

- Housing is a key issue for Sydney. In the next two decades, 725,000 new homes will be needed in Sydney metropolitan area (36,250 new homes each year).
- More than 5,000 per year of social and affordable housing is required and currently only 10,000 is planned for the next 20 years. A volume solution is needed to turn this around.
- Well aligned housing policy, land use strategy and planning mechanisms supported by clear targets, funding and leadership at all levels of government and industry is needed to support quantum increase in social and affordable housing.
- The market is not delivering sufficient affordable housing stock for low and moderate income households across much of Sydney – notwithstanding record approvals and completions.

#### **Essential Infrastructure**

 Recognise and approach affordable housing as essential infrastructure for a sustainable, fair and productive city.

#### Affordable housing as approach to housing affordability

 Housing affordability is a serious issue facing greater Sydney, and enabling provision of affordable housing to low and moderate income earners provides a critical piece of the overall solution to the housing crisis.

#### Affordable housing and economic competitiveness

- Affordable housing enhances the economic competiveness of Sydney and benefits households who need to live and work in here which otherwise would be unaffordable.
- Essential workers on low to moderate incomes cannot afford to live in Sydney.

#### AFFORDABLE HOUSING POLICY AND STRATEGY

The following policy and strategy measures are crucial to sustainable affordable housing in NSW:

- The Federal, NSW and local governments need to identify unused and underutilised land that may be suitable for affordable housing.
- A NSW housing policy that identifies the planning, funding and delivery of affordable housing, alongside measures to improve housing affordability.
- A NSW housing policy that defines affordable housing and uses the accepted 'very low to moderate income' definition universally.
- Scope the quantity and nature of housing needed and require affordable housing targets to be addressed in metropolitan, district and regional plans.
- District, Precinct and Local Council's Community Strategic Plans should state affordable housing targets and housing mix for a diverse community.
- State-Council collaborative approach and guidance on achieving the right balance between State Infrastructure Contributions / Affordable Housing Contributions / s94 Local Infrastructure Contributions.
- Establish a single statutory planning policy framework (Model Code) for the application of inclusionary zoning measures, density bonuses and compensatory measures for affordable housing, including consolidating relevant SEPP70 and ARHSEPP provisions.

#### PLANNING MECHANISMS AND AFFORDABLE HOUSING

#### State and planning mechanisms

- Transparent criteria are required for councils to apply (opt-in) inclusionary zoning model code.
- Investigate options for flexible development standards for affordable housing.
- Concessions should be permissible for s94 in exchange for affordable housing.
- Need to include affordable housing as an object in the EP&A Act.
- Review SEPP 70 and update SEPP Codes to include Affordable housing with the ability for councils to insert specific ratios or parameters based on Local Housing Needs study.
- Enable councils to include a mandatory requirement for affordable housing in their LEPs where there is land value uplift to support its application, including in government land.

#### Councils and planning mechanisms

- Provide enabling mechanisms and require all Councils to adopt, monitor and report against need based strategies and Affordable Housing Target as part of their annual reporting requirements.
- Facilitate planning agreement process that is streamlined to provide guidance on land value uplift capture and on the use of planning agreement for affordable housing.
- Faster approvals for DAs that include affordable housing, supported by improved assessment resources and officers.

#### **Role for the Community Housing Providers sector**

- ensure that the affordable rental accommodation created in accordance with affordable housing targets are dedicated as affordable rental housing in perpetuity, and managed by a Community Housing Provider.
- use state land to create affordable housing as part of mixed tenure developments, developed and managed in partnerships with Registered Community Housing Providers.

#### URBAN RENEWAL AND AFFORDABLE HOUSING

#### Affordable housing targets

- Affordable housing targets for a local government area should be justified by an adopted local housing strategy, including housing needs assessment.
- Common demand modelling / feasibility testing methodologies should be used for justifying targets
- Evidence based affordable housing targets should be set for urban renewal precincts / LGAs and higher targets on government owned land, especially where there is a Growth Infrastructure Compact or relevant City Deal.
- Set affordable housing targets of 5-15% in new large developments and precincts and higher targets for state owned lands (up to 20%).
- The target could also be applicable across the board in jurisdictions where there is identified severe affordable housing need.
- Transparent modelling and methodologies should be the basis for housing targets.

#### **Growth Infrastructure Compacts**

- There is need for State-Council collaborative 'Growth Infrastructure Compact' for large redevelopment and urban renewal precincts, including affordable housing targets and community engagement protocols.
- Identify urban renewal precincts where VPAs can better deliver affordable housing, especially through dedication of land or dwellings.

#### Sydenham-Bankstown Corridor

 Recognise Sydenham-Bankstown Corridor as priority target for affordable housing in the Central and South Districts and should be subject to Growth Infrastructure Compact agreement.

#### FINANCING AND FUNDING

#### Affordable housing as part of infrastructure funding mix

- Recognise affordable housing as a component of infrastructure to be funded for sustainable cities. Mechanism needed to ensure affordable housing funding should be part of the infrastructure mix identified in growth infrastructure plans.
- Open and transparent affordable housing contribution costs and embedded in land price.

#### **Bond aggregator**

• Bond aggregator is supported to enable access to lower cost finance at scale.

#### Value capture

- Jurisdictions should adopt consistent value capture policy.
- Recognise that there is a legitimate basis for value capture mechanisms as 'development licencing fees'.
- Adopt consensus position capturing 50% of value uplift as 'development' licence fee' disbursed according to a growth area 'compact' agreement.
- Value capture framework for jurisdictions, example, a district, could be tailored to local parameters.
- The details of value capture scheme should be available early or phased-in to reduce impact on feasibility.
- Feasibility testing for value capture should be completed upfront at the strategic study stage to determine an appropriate value capture rate. This approach ensures that a value capture policy and approach is transparent and that developers do not build a case at the assessment stage of unviability because they have already paid too much for the land.

#### Contributions

- Contributions obligation need to be made known at the very time growth area structure plans are released.
- Contributions should be preferably land or dwellings rather than cash in lieu due to high cost of land for affordable housing.

#### Affordable housing models

- Promote 'Build to rent' options.
- Promote small dwelling affordable housing and with measures to maintain design quality.
- Promote multi-family housing options.
- Develop shared equity programs with the NSW Federation of Housing Associations to provide affordable housing purchase products accessible to low income and moderate income households with children.
- The Federal Government should support an affordable housing growth fund (tax credits, grants) matched by states to replace the National Rental Affordability Scheme.
- Affordable housing rents are insufficient to fully cover operating costs or fund new supply and ongoing subsidy is needed for funding gap.
- Support for building standards that minimise energy and ongoing maintenance needs.

#### The Missing Middle

- New approach needed for the "missing middle" the vast parts of Sydney zoned for low density housing with good access to public transport and existing social infrastructure, particularly the established middle ring suburbs.
- Intergenerational housing forms needs to be considered. This could be in form of a new zone category for "un-subdividable build to rent multi family home". Alternatively, the "Manor house" approach could be adopted.
- A Manor house could be defined as a permissible use in the development control table for R2 zones and could contain up to 4 separate dwellings. No changes to the development standards, FSR, height, setbacks and landscape requirements are required. This form of housing will promote the idea of small dwellings, maximise use of existing underutilised infrastructure, provide intergenerational housing, increase the potential for affordable housing rental options and allow for greater housing diversity.

#### Funding and delivery approaches

- Consistent inclusionary zoning (density bonus) model code enabled by District Plan and the parameters set in a local housing strategy.
- Incentivise occupancy for rental investment properties.
- Support for programs to transition from affordable housing to rental market or purchase.
- Increase promotion of affordable housing and of eligibility requirements community education about affordable housing.
- Endorse the key role for Community Housing Providers to manage affordable housing in perpetuity
- Increased State and Commonwealth Government investment in social housing alongside affordable housing delivery.

#### SYDNEY METRO WEST PROJECT

I refer to the recently announced Sydney Metro West project between Parramatta and the Sydney CBD.

The announcement of the project in November 2016 stated that the proposed new metro is planned to service key growth precincts of Parramatta, Sydney Olympic Park, the Bays Precinct and Sydney CBD.

Burwood has not been identified in the announcement, however, in the State Government's own planning documents such as The Department of Planning "Plan for Sydney 2036" and the Greater Sydney Planning Commission "Draft Sydney Plan", Burwood is listed as a Strategic Centre and District Centre.

It is noted that the above categorisations mean that Burwood is the only Centre in the Inner West that has been identified as a Strategic Centre with the need to maximise capacity for both population and employment targets.

One of the key reasons for constructing the new Western Metro Line is the need to ease pressure on the main Western Rail Line, which is heavily used and expected to reach capacity within the next 15 years.

The existing Burwood Train Station is about the eleventh busiest station on the existing Sydney Rail Network and with increased movements expected due to Burwood being a Strategic Centre, the need for better transport options has never been greater.

Despite sharing the same status with Sydney Olympic Park as a Strategic Centre, Burwood has not been listed in the announcement as a place that the new Metro West Rail Line would service.

Burwood Council, at its meeting of 23 May 2017, considered the matter and resolved inter alia:

That Burwood Council write to the Premier, the Hon Gladys Berejiklian MP, Minister for Transport and Infrastructure, the Hon Andrew Constance MP, the Greater Sydney Planning Commission Chief Commissioner, Lucy Turnbull and the Central District Commissioner, Marie Atkins, Local Government NSW, SSROC and the Urban Taskforce requesting urgent meetings to seek their support and commitment to include Burwood on the list of proposed stations for the new Western Metro Rail

- That Council seek broader support from both the Southern Sydney Regional Organisation of Councils (SSROC) and the Western Sydney Regional Organisation of Councils (WSROC) for our campaign

#### **Planning and Advocacy**











The Affordable Housing Forum held on Monday, 24 July 2017, coordinated by SSROC and partners the Planning Institute of Australia (PIA) and the NSW Federation of Housing Associations, was an unmitigated success with 198 registered delegates.

Of the initial feedback received, all was positive or neutral, with the most common written feedback being praise for an excellent event, informative speakers, and anticipation of the communique as a useful outcome and tool.

The Forum provided a wealth of information, resources, networks, and ideas. The ideas generated from the Forum conclusions will be developed into a communique which will be distributed shortly. This will result in several advocacy projects and ongoing advocacy work for SSROC, specifically in relation to value capture.

The outcomes for SSROC were manifold, with media coverage, social media engagement, valuable contacts and networks established, and wide promotion of the work that SSROC undertakes on behalf of its member councils.

## Call for Expressions of Interest

#### UTS PhD Scholarship Vulnerability, Health and Environmental Risk

There is growing interest in how vulnerable populations deal with environmental risk, particularly in terms of contaminated lands. NSW alone has an estimated 30,000 contaminated sites. An estimated 1,600 of these sites pose significant risks that require intervention to limit danger to human health and the environment. Vulnerable populations are particularly prone to contaminant risk.



The Institute for Sustainable Futures and Faculty of Health, University of Technology Sydney are seeking a PhD student (Australian citizen or permanent resident) to undertake collaborative research on 'how vulnerable populations deal with environmental risk'. ## Waste Avoidance and Resource Recovery

The WARR team at SSROC has been working hard on a number of important projects in line with the SSROC Waste and Resource Recovery Strategy and regional priority projects. The SSROC Waste and Resource Recovery Strategy is currently being revised and updated to ensure the Strategy is current and is in line with regional priorities.

### Veolia Advanced Waste Treatment Services



### Woodlawn waste processing facility

After more than 8 years of hard work, savvy negotiations and representation on behalf of our councils, SSROC is pleased to advise the official opening of the Veolia Woodlawn mechanical and biological treatment facility has been announced for 8 September 2017, with formal invitations being sent early August.

The Opening will be attended by the Hon Gabrielle Upton, Minister for Environment, Local Government and Heritage; the Hon Pru Goward, Minister for Family and Community Services, Social Housing and for the Prevention of Domestic Violence and Sexual Assault, and State Member for Goulburn; and the Hon Angus Taylor, Assistant Minister for Cities and Digital Transformation and Federal Member for Hume.

Waste from 6 councils is being processed at Woodlawn instead of being landfilled. With 50 to 60% diversion of general waste (red-lid bin) from landfill, saving councils millions of dollars in waste levy and increasing those councils overall diversion to around 70%. The facility is generating compost for use in mine-site rehabilitation, with metals and plastics extracted and recycled.



Surplus heat generated will be used for aquaculture in a water-neutral process.

The waste is moved by rail from the Banksmeadow Transfer Station, reducing truck movements by around 30,000. More than 50 jobs have been created at Banksmeadow, in Bayside LGA, and Woodlawn in regional NSW.

## Waste Less Recycle More Education Project

The community waste educators program concluded its first year, holding 131 workshops for more than 2,200 participants from 78 different community groups. Seventy-five percent of workshops were delivered to culturally and linguistically diverse audiences (CALD).



The impact of the program was evaluated, with 1,588 (94%) participants committing to an action to reduce waste, measured through self-reports and text messages. One month after workshops the participants who had provided mobile contacts were asked if they had undertaken their action, with 44% responding and of those, 80% said they had successfully completed their action.

SSROC is pleased to advise that this very successful program has been extended through 17/18.

#### **Stop Bus Stop Litter**

SSROC has acquitted our Stop Bus Stop Litter grant, which was rolled out across three councils. This project conducted observational research and infrastructure upgrades at bus stop litter hotspots. On average, there has been over 80% success in measured litter counts because of each intervention.



# Improving Recycling & Reducing Contamination in Multi Unit Dwellings & ROCovering Organics Environmental Trust Grant

Both the ROCovering Organics
Environmental Trust Grant and the
Improving recycling and reducing
contamination in multi-unit dwellings
(MUDs) projects are now concluding.
Roger Bramble, one of our Regional
Strategic Coordinators will also be
finishing up alongside these projects as
his position's EPA funding is concluding.
We wish Roger all the very best for his
future.



Key achievements of the projects:

- Sales of organics infrastructure in June reached over 1,000 units
   the highest ever throughout the grant period.
- Final reporting on the MUDs project is due in late August which will inform councils on evidence based waste reduction and materials separation interventions at multi-unit dwellings.



#### Growing the Community Reuse & Recycling Sector in Greater Sydney

SSROC is taking a leading role to link ROCs, Joint Organisations and NSW EPA to support the Community Recycling (and Reuse) Network of Australia (CRNA) to conduct focused and sustained operations on behalf of its enterprises, from Hunter to Illawarra and west to the Blue Mountains, in the greater Sydney local government area.

Did you know <u>The Bower</u> is an example of an enterprise that could get involved in this project?

The CRN-Sydney network will be launched shortly, keep an eye out for updates.

## Waste Avoidance and Resource Recovery (WARR) updates

The WARR team has been holding consultation workshops with member councils as part of their three-yearly updating of the SSROC regional waste avoidance and resource recovery strategy. They have an August workshop focusing on scoping on the more complex projects for the coming 4 years.

We are thrilled to advise that the Bower reuse and rehoming services have had their contracted extended for a final 12 months, with councils entering the final year of this contract. It is exciting to note that there has been a 24% increase in participating households.

SSROC General Manager, Namoi Dougall, and WARR Regional Strategic Coordinator, Hazel Storey, were invited to present at NSW Parliamentary Enquiry into waste management and the Energy from Waste Inquiry. It is excellent that SSROC is being recognised for our expertise regarding energy from waste, and broader waste issues including reuse.

The Sydney RID Squad contract has been extended for another 12 months, comprising eight SSROC councils. We facilitate program inputs for the RID program, including research, analysis, and evaluation, and we currently chair the regional RID meetings.



#### **Procurement**

The SSROC Procurement team has been delivering excellent results to our members, with SSROC procuring goods and services in excess of \$100 million in the 2015-16 Financial Year. It is estimated that through careful negotiations and competitive tendering, SSROC has been able to deliver savings of more than \$19 million to member councils.



We are pleased to advise that we expect excellent results for our 2016-17 financial year, with our Procurement team continuing to deliver value-for-money on joint procurement of regional contracts and shared services.

During the 2016-2017 financial year, SSROC will undertake numerous retenders of existing regional contracts, with over 20 planned sourcing activities covering the procurement of goods and services including temporary staff hire, ready mixed concrete, mattress collection and processing, and code of conduct advisory services.

## Program for Energy & Environmental Risk Solutions (PEERS)



The joint regional PEERS Program is designed to help councils mitigate rapidly escalating and increasingly volatile prices for electricity and gas while also helping them meet their environmental goals in an integrated manner. It will do this through an integrated program involving large-scale aggregated buying of electricity and gas, energy efficiency services and potentially, a renewable power purchase agreement.

The National Electricity Market and natural gas supply situation have changed markedly in recent years in ways that are now having dramatic impacts on prices and creating an urgent need for councils to adapt and respond to energy cost risk.

The current electricity contract is the largest and most successful electricity tender for councils in NSW, achieving some of the lowest pricing available

through a very large collective procurement. It expires on 30 June 2018. With this next procurement, we aim to mitigate the risk of councils' electricity and gas costs increasing by 200-300% through some innovative approaches, which will also help lower greenhouse gas emissions.

Background:	SSROC plans, manages and delivers a range of projects in response to the needs of member councils. These may be initiated by the ROC Committees, General Managers, officers in working groups, or in response to opportunities that arise.
Current status:	<b>Veolia AWT Services Contract</b> – Deeds of Amendment have been executed by all participating councils except Georges River and Bayside; most of their required changes have been accepted by Veolia, and their suggestions for resolving the few remaining issues are with Bayside for review. Financial and quality controls are being reviewed by SSROC's internal auditor and by our independent technical adviser.
	A formal launch at Woodlawn is planned for 8 September 2017 (Woodlawn is near Tarago, 250km south-west of Sydney).
	Regional Waste and Resource Recovery Strategy The allocation of the regional Better Waste and Recycling funding of \$391,000 (previously \$464,413) has been agreed by the Strategy Steering Committee and approved by SSROC General Managers (see Attachment 1). The strategy review and update project continues, due for completion by October 2017.
	Implementation Coordination Work continues on: supporting the Sydney RID Squad, developing the reuse sector, clean-up tender(s), mattress recycling tender, advocacy, regional bin audit, litter bin placement guidelines, container deposit scheme implications analysis, and waste education.
	Connected Corridors for Biodiversity Sufficient funds remain in the project budget to develop and deliver seven community workshops. To date Bayside, Canterbury-Bankstown, Inner West, Sutherland and Sydney have agreed to host workshops, so two further workshops are available.

#### ITEM 8.3 Community Energy Service

#### **RECOMMENDATION:**

That SSROC Delegates:

1. Receive and note the report.

Purpose of the report:	To inform Delegates of a new Community Energy Service that will be provided to residents under the regional Renewable Energy Master Plan: Our Energy Future.
Background:	One of the actions identified in Our Energy Future was the establishment of a Community Energy Service, to help residents and local businesses to make informed decisions about energy efficiency actions and renewable energy.
	Following the appointment of Positive Charge as the preferred supplier of this service for a pilot project, a launch was held on 21 June 2017. The event attracted very good attendance including Councillors, council officers, officers from the Office of Environment and Heritage, and from the Renewable Energy Advocate.
Current status:	The pilot is now fully operational. A report has been delivered to each Council showing performance during the set-up months of the pilot. Across the participating councils from April to June 2017 there were 57 registrations, 8 solar PV installations totalling 29kW. This is equivalent to 807 tonnes of CO <sub>2</sub> -e abated, and cost savings of \$6,882 p.a.  A range of marketing campaigns and other services have been scheduled and are being
	delivered. If the pilot is successful, then Councils will be able to continue to subscribe annually, and Positive Charge will open the service to more Councils.
	Participating Councils: Bayside, Canada Bay, Georges River, Canterbury-Bankstown, Inner West, Parramatta, City of Sydney, Randwick, Waverley and Woollahra.

Background:	SSROC maintains approximately thirty (30) regional contracts on behalf of member Councils and aims to continuously improve its offer through better value, business alignment and service improvement.
Current status:	SSROC Contracts Table 1 (attached) lists current regional contracts available to member councils. Table 2 shows the participation of Councils in various contracts.  Current Sourcing Activity

The following procurement was released to open market:

## Program for Energy and Environmental Risk (PEERS)

The energy efficiency stream of the PEERS program consists of three separate Requests for Quotations (RFQs):

The aim is to create expert panels through preferred supplier agreements, members of which can provide independent advice to Councils on efficiency measures that will result in reduced energy usage. (See further information on PEERS in item 8.5).

The following procurements are currently being evaluated and finalised:

#### Hardware

This tender was released to the open market on 4 July and closed on 27 July. Submissions are currently being evaluated. The scope of the goods required has been reviewed and expanded by councils. Randwick Council is hosting the tender on behalf of SSROC. All member councils are participating in this tender.

#### **Plants and Trees**

This tender for the supply of plants and trees was released to the open market on 20 June and closed on 11 July. Sutherland Shire Council hosted the tender on behalf of SSROC. Nine (9) councils are participating in this process. The submissions have been evaluated

and a tender recommendation report with the recommended composition of the supplier panel will be provided to the participating Councils.

## **Temporary Staff**

This tender was released to the market on 30 May and closed on 20 June. Twenty-eight companies (28) have responded to the tender. The evaluation has been completed and the tender recommendation report accepted by the nine (9) member councils. Preferred Supplier Management Agreements (PSMAs) have been sent out to be signed by each supplier.

The following procurement projects have been cancelled:

# Council Owned Lighting Tender (COLT) Category 4 – Outdoor Control Systems Sixteen (16) Councils from SSROC and outside the area participated in the tender. All

tenders were rejected as detailed in the Tender Recommendation Report:

All suppliers were rejected from this category as the cost to councils, as an individual entity, of setting up a communications network were to great and would require years to replace lighting to complete the network

Negotiations with the tenderers commenced and it became clear that there was a latent demand in Councils to use smart controllers not just for outdoor lighting, but for other infrastructure as well, such as garbage bins and parking spaces. But Councils do not uniformly know exactly what assets they want to control, or how they want to deploy such technology. This scope increase, while providing exciting new opportunities, was not part of the initial tender proposal. With the technology itself also evolving rapidly, the negotiation panel agreed that it was best to cease negotiations, and go out to tender with revised scope in 12-18 months. This will give SSROC and Councils time to firm up what assets, smart controllers should be used for. This information will be used together with the lessons and valuable market information gained from this tender.

## Heating, Ventilation and Air-conditioning (HVAC) – Install and Maintain

It was not considered appropriate to continue with the tender process yet. The better option is to complete the PEERS HVAC process first to give Councils access to independent advice and an opportunity to review their HVAC systems. Then this HVAC installation and maintenance tender could be run on a more informed basis.

The following procurements are work in progress and have not yet been released to market:

## **Mattress Collection and Disposal**

The specifications for this tender are currently being developed by the working group. The working group requires more time due to the uncertainties of the mergers and also bringing the Mattress RFT and the Clean Up RFT into alignment. It is expected that this tender will go to the open market in the first week of December, closing at the end of January. Ten (10) member councils are participating.

### Clean Up (kerbside waste resource recovery and recycling)

The specifications for this tender are currently being developed by the working group. Georges River Council will host this tender. A market sounding meeting was held on 19 July 2017 after advertising in the Sydney Morning Herald. Major suppliers responded to set questions, which will inform the future tender process. In terms of procurement, key

issues for consideration by SSROC and member councils are:

Risk sharing, in particular waste volumes, and partnership arrangements Shorter term contracts due to large number of variables New market players are looking for opportunities and more open to innovation

## **Bush Regeneration**

Specifications for this tender are currently being developed.

## **Joint Council Energy Procurement**

The SSROC energy contract expires on 30 June 2018. Due to the high level of volatility in the market, it has been decided to move on this procurement much earlier than anticipated. (See separate report at item 8.5).

## **Architect/Design and Construct**

Development of the specification for this has not yet begun. Council procurement officers have been requested to discuss their design requirements with their councils however most have indicated that they do not require this service.

## **Contracts for Re-tender in 2017**

During the second half of 2017, following the approval of the Supply Management Group the following RFT's will be developed for re-tendering in early 2018:

- Phone and Communication Systems
- Parking Infringement Papers

## ITEM 8.5 Program for Energy and Environmental Risk Solutions (PEERS)

## **RECOMMENDATION:**

That SSROC Delegates:

1. Receive and note the report.

## Purpose of the report:

To advise Delegates of this new major SSROC initiative.

### Background:

With the escalating prices of electricity and gas, we anticipate that the next electricity supply procurement would deliver prices more than double those that councils currently pay. We have therefore developed the Program for Energy and Environmental Risk Solutions (PEERS) to mitigate the risk of those likely price increases through four interconnected streams of work:

- 1. Bulk procurement of grid electricity, to include large sites, street-lighting and small sites as the current contract does:
- 2. Enabling energy efficiency through the establishment of panel contracts for expert advice on air-conditioning and lighting, and for sub-metering and analysis, which will facilitate councils reducing their demand for electricity;
- Increasing renewable energy consumption through a renewable energy power purchase agreement: with costs of wind and solar generation falling, this could prove a lower cost source of a proportion of electricity, as well as helping councils to achieve their sustainability targets;
- 4. Bulk procurement of gas supply.

The aims of the project are to:

#### **Save Money**

Aggregating electricity sites across the state will result in increased buying power and reduced prices for Electricity and, if viable, Gas.

#### **Receive Better Service**

Large aggregate procurement will place the group into the top tiers of energy buyers which will mean access to dedicated account managers and better service from the supplier.

## Minimise Risk

In a volatile energy market which has seen electricity and gas costs more than double, we aim to manage risk through an innovative approach using a renewable energy PPA and strategically timing our entry and exit into the market.

#### **Lower Greenhouse Gas emissions**

This will be achieved by helping councils reduce the energy they need and through a renewable energy PPA. The project will also have expert panels set-up that Councils can access for advice and services for efficiency gains relating to Air-conditioning, Indoor Lighting, and Smart Metering

## **Build on Past Success for the Future**

Our current electricity contract is one of the largest and most successful electricity tenders for councils in NSW that resulted in a combined \$7million saving for participants this year alone. We can leverage this experience to continue to generate savings and efficiencies for all Councils through this tender process and into the future.

## **Current status:**

The proposal for councils to participate in the each of the four streams of this program (Attachment 1) has been developed and distributed to potential participants.

Two forums are scheduled for 14 August 2017 to provide information to interested councils.

A commitment to participate will take the form of a memorandum of understanding and a contribution to the up-front costs of the program.

## Buy Together, Buy Smarter, Buy Better


#### Introduction


The joint regional PEERS Program is designed to help councils mitigate rapidly escalating and increasingly volatile prices for electricity and gas while also helping them meet their environmental goals in an integrated manner. It will do this through an integrated program involving large-scale aggregated buying of electricity and gas, energy efficiency services and potentially, a renewable power purchase agreement.

The National Electricity Market and natural gas supply situation have changed markedly in recent years in ways that are now having dramatic impacts on prices and creating an urgent need for councils to adapt and respond to energy cost risk. Of particular note are three key developments:

- The closure of some older coal-fired generators in the National Electricity Market and the continuing uncertainty about national greenhouse gas emissions policy has resulted in fewer new energy generating plants being built in recent years. This has led to a progressive tightening of electricity supply, higher prices and increased volatility in what was a previously an over-supplied electricity market for much of the past two decades.
- Increased natural gas exports and resulting tighter domestic gas supplies has
  occurred at a time when gas-fired electricity generation is playing an ever-greater
  role in meeting peak electricity demand. The gas and electricity markets are
  therefore increasingly inter-related. Because of this greater inter-relationship,
  tightening of supplies in one market is having a price effect in the other.
- There has been a progressive reduction in the costs of renewable energy and battery technologies to a point where, for the first time, wholesale renewable Power Purchase Agreements (PPAs) have been available at lower cost than wholesale electricity costs in the National Electricity Market.

The graphs below illustrate the price impact at a wholesale and retail level that has made energy pricing and policy a front-page story in recent months.





To help councils mitigate the impact of these developments, the PEERS Program integrates the following four streams which are further described in this PEERS Program overview:

- 1. **ELECTRICITY** Joint tender for electricity (Large Sites, Small Sites, GreenPower)
- 2. **GAS** Joint tender for natural gas (Large, Medium & Small Sites)
- 3. **ENERGY EFFICIENCY** Joint RFQs for panels able to supply electricity submetering and analytics, HVAC specialists and lighting specialists
- 4. **RENEWABLE ENERGY PPA** Joint tender for one or more electricity off-take agreement(s) for renewable energy and environmental certificates (LGCs)

## 1) Electricity Procurement

## Introduction

Over three successive tenders, Southern Sydney Regional Oranisation of Councils Inc. (SSROC) has consistently achieved some of the lowest electricity pricing for NSW councils because of the inherently sound economic design of its tender process. The process features: 1) large group aggregation of buying power with council contract dates aligned and on the same terms; 2) a full open market tender targeting all



licensed NSW electricity retailers, not just a limited tender panel of retailers; and 3) seeking expert advice from a panel of independent consultants.

Overall, the estimated benefit for councils in aggregated buying is at 2-5% and importantly, at or above the volume being procured under the PEERS process, savings are not only at the upper end of this range but this volume opens up negotiations on standard terms and conditions. Market timing can also be a highly significant factor in savings. While other councils are facing dramatic electricity price increases this year, SSROC's current electricity contract was signed at a low point in the market for the maximum duration possible. In this year alone, the savings for 17 participating councils are in the order of \$7 million compared to current pricing. With dramatically higher prices in the market, large group buying and expert advice on the timing to market and contract duration is the best possible approach to keeping future price increases to a minimum.

## **Summary of Approach**

- Joint open market tender to all licenced NSW electricity retailers seeking one, two and three-year pricing for large sites, small sites and GreenPower
- Will take into consideration renewable PPA input (see Stream 4) and energy efficiency forecasts (see Stream 3)
- Aligned procurement dates wherever possible (17 councils totalling ~100,000 MWhr/yr already on 1 July 2018 start date with flexibility to accommodate other start dates)
- Panel of two to three independent expert advisers to advise on forecasting of load, specification development, timing to market, contract duration and assistance in negotiation of terms with finalists

## Costs

Councils will be charged fixed fees of \$12,500 + GST (50% payable on signing MOU and 50% on release of tender) and on-going fees of 0.5% of retail energy costs will be charged to the winning tenderer. These fees are a maximum based on the number of councils in the existing SSROC contract. They will be reduced if more councils join. SSROC has chosen to charge up-front fees for transparency, and a small trailing commission so that overall fees reflect actual volume purchased by each council. The fees are below typical costs of each council staging a medium-sized tender.

## 2) Natural Gas Procurement

## Introduction

Like electricity prices, natural gas prices have doubled in the past 12 months and councils are likely to benefit from aggregated buying of gas, particularly for their main building, recreation centres and other facilities that have appreciable gas consumption. SSROC is proposing to apply a gas procurement methodology similar to that which it has successfully used for electricity procurement. The process will feature: 1) large group aggregation of buying power for natural



gas with council contract dates progressively aligned and on the same terms; 2) a full open market tender targeting all licensed NSW gas retailers; and 3) seeking expert advice from a panel of independent consultants.

With dramatically higher prices and significant volatility in the gas market, large group buying and expert advice on the timing to market and contract duration is the best possible approach to keeping future price increases to a minimum.

## **Summary of Approach**

- Joint open market tender to all licenced NSW gas retailers seeking pricing for all small (sub-1 TJ p.a.), medium (1-10 TJ p.a.) and large (10 TJ+p.a.) sites
- Progressively align procurement dates wherever possible
- Panel of two-three independent expert advisers to advise on forecasting of load, flexibility, specification development, timing to market, contract duration and assistance in negotiation of terms with finalists

## **Costs**

Councils will be charged fixed fees of \$12,500 + GST (50% payable on signing MOU and 50% on release of tender) and on-going fees of 0.5% of retail energy costs will be charged to the winning tenderer. These fees are a maximum based on the number of councils in the existing SSROC contract. They will be reduced if more councils join. SSROC has chosen to charge up-front fees for transparency, and a small trailing commission so that overall fees reflect actual volume purchased by each council. The fees are below typical costs of each council staging a medium-sized tender.

## 3) Energy Efficiency Services Procurement

## Introduction

Cutting electricity consumption is one of the most effective strategies that councils can adopt to cut costs and reduce their exposure to volatile electricity prices. While most councils have already undertaken a range of energy efficiency initiatives, many opportunities need to be revisited and more steps need to be taken in the context of a doubling of prevailing electricity prices.



Based on advice, PEERS focuses on assisting councils to implement more aggressive energy efficiency through three proven strategies: deployment of sub-metering and data analytics; securing a panel of independent expert HVAC consultants; and securing a panel of independent expert lighting consultants.

## **Summary of Approach**

- Through an RFQ process, provide councils with a panel of sub-metering / data analytics suppliers that are able to implement sub-metering solutions in councils' largest sites to:
  - quantify energy usage of major systems;
  - o provide on-going near real-time monitoring of consumption; and
  - implementing software that can accept data feeds from sub-meters, provide trend analysis, threshold monitoring, alarm outputs and help identify energy efficiency opportunities and produce action-oriented recommendations for reducing consumption.
- Through an RFQ process, provide councils with a panel of independent expert HVAC consultants that can assess HVAC operations across a portfolio of sites to identify opportunities for improvement in either the operation of existing systems or make recommendations for the cost-effective upgrade or replacement of existing systems.
- Through an RFQ process, provide councils with a panel of independent expert lighting consultants that can assess lighting systems across a portfolio of sites to identify opportunities for improvement in either the operation of existing systems or make recommendations for the cost-effective upgrade or replacement of existing systems.

#### Costs

Councils will be charged an up-front fee of \$1500 + GST to cover the costs of the three RFQs and there will be no on-going fees for councils or suppliers under these panels.

## 4) Renewables Power Purchase Agreement

## Introduction

In recent months, wholesale contracts for renewably-generated electricity have been offered at lower costs than regular grid electricity (as much as \$30-\$50/MWh below total delivered energy costs under a standard retail contract). SSROC aims to help PEERS participants take full advantage of this by aggregating load, to again improve on buying power compared to that of individual councils, and approach the market for the best renewable energy rates available.



A request for proposals (RFP) will seek pricing for electricity and renewable energy certificates for a portion of up to 50% of council loads. Targeted for release in September 2017, the RFP will clearly stipulate that pricing must be cheaper than regular grid energy or councils will not proceed. Importantly, this renewables procurement process is happening **before** the PEERS electricity tender (Stream 1), allowing for any renewable electricity purchased to be deducted from the electricity load to be procured in the regular retail market. This approach is in keeping with the strategy being adopted by many large commercial and industrial customers in response to the current market conditions.

Renewably-generated electricity will likely be offered under a Power Purchase Agreement (PPA), whereby all the costs of the renewable generator are rolled up into a single rate per kilowatt hour. The PPA would have a longer term than a typical retail electricity contract as this allows the generator's costs to be spread over a longer period, reducing the rate per kilowatt hour. This could provide councils with significant price stability benefits for part of their load in a highly volatile market.

Renewable energy generators and new project developers are currently highly motivated vendors as they wish to secure long-term contracts in the current energy market and are ready to negotiate with creditworthy counterparties such as councils.

## **Summary of Approach**

- Joint open market RFP to renewable energy generators and new project developers using any renewable energy technology (wind, solar or other)
- Approach the market early to ensure that generation can begin within the next regular electricity contract period (and be accounted for in those contracts)
- Retain the ability for councils to opt out prior to commencement, should pricing be more expensive than grid power

#### Costs

Councils will be charged fixed fees of \$15,000 + GST (50% payable on signing MOU and 50% on release of tender). On-going fees of 0.5% of retail energy costs will be charged to the winning tenderer. These fees are a maximum based on the number of councils in the existing SSROC contract. They will be reduced if more councils join. SSROC has chosen to charge up-front fees for transparency, and a small trailing commission so that overall fees reflect actual volume purchased by each council. The fees are below typical costs of each council staging a medium-sized tender.

## **Commercial Arrangements**

Councils seeking to participate may choose to be involved in any and all PEERS Streams on the commercial terms for each Stream outlined above. Councils do not need to participate in the whole program but must clearly commit, through the signing of an MOU with SSROC, to the Streams in which they wish to participate. Deadlines for confirming participation in each Stream are as follows:

1. Electricity Procurement

2. Gas Procurement

3. Energy Efficiency Services Procurement

4. Renewables Power Purchase Agreement


## **Next Steps for Councils Seeking to Participate**

- 1. Provide an initial indication of interest to SSROC and nominate a primary contact
- 2. Sign an MOU with SSROC for each Stream in which council wishes to participate
- 3. Provide details of all electricity/gas accounts, consumption information and authorisation for SSROC and its advisers to access account details to validate data

## **Integrated Timetable**

The overall aim of PEERS is to help councils reduce what they need to buy through the adoption of well-proven energy efficiency services, and readily available, secure direct agreements with one or more renewable energy suppliers – if it can be demonstrated to be lower cost than the prevailing rates in the regular retail market – and then procure electricity in the regular market to meet the remaining load (which may well be a declining load over time for many councils). These three electricity-related Streams are therefore closely linked and this is reflected in the timetable below.

With regards to gas, the overall aim of PEERS is to bring the same disciplined process and structure to gas procurement that has been so successful for councils with electricity. The timetable for this process recognises that there is a range of current gas procurement arrangements within councils at present and that information gathering and validation may take somewhat longer.

#### SECTION 9. EXTERNALLY FUNDED PROJECTS

## ITEM 9.1 Street Lighting Improvement Program Update

#### **RECOMMENDATION:**

That SSROC Delegates:

1. Receive and note the report.

# Purpose of the report:

To inform Delegates of progress and to highlight issues arising

#### **Current status:**

The SSROC SLI Program, numbering 30 councils and 95% of the street lights in the Ausgrid region, has been involved in several on-going street lighting activities in recent months. The status of these is as follows:

## **Accelerated Replacements Negotiations Nearing Conclusion**

With agreement on LED pricing earlier this year, SSROC's top priority has shifted to negotiating a program of accelerated replacements of old street lighting on residential roads with LEDs. Under discussion is the replacement of 101,000 street lights on residential roads could be replaced over the next three years. This is about 40% of the lighting for each council. The SSROC SLI Program is awaiting one final input from Ausgrid to finalise the jointly developed business case modelling. Ausgrid is expected to soon invite all councils to a joint meeting to present this as a proposal. SSROC will be providing supporting material laying out the business case for accelerated replacements. SSROC has, in parallel with Ausgrid negotiations, held further discussions with the Office of Environment & Heritage about the potential for funding support and with the Clean Energy Finance Corporation (CEFC) about the potential to improve the business case for councils by using external capital instead of Ausgrid financing. The CEFC has now provided indicative costs for this approach.

#### **Main Road LED and Smart Controls Trials**

Many councils submitted proposed main road LED trial sites earlier this year and nine have been selected. Some 600 LEDs are expected to be deployed on main roads in the coming weeks in conjunction with a recently agreed trial of smart controls. Ausgrid is expected to tender for main road LEDs in the next few months with the objective of adopting LEDs as the standard lights for main roads later this year and potentially adopting smart controls for main roads as well. SSROC is working with Ausgrid to progress these trials as quickly as possible and has requested a copy of Ausgrid's specification to be able to undertake a review on behalf of councils and to initiate discussions with the RMS to ensure their support.

## AER 2019-2024 Pricing Review

The next Australian Energy Regulator's review of electricity distribution pricing for 2019-2024 has commenced. SSROC's preliminary submission strongly advocating for continued regulatory oversight of street lighting in the review was accepted. SSROC intends to play an active role in the street lighting aspects of the review. Councils have collectively pushed back Ausgrid pricing by more than \$20 million in each of the last three pricing reviews by working together through the SSROC SLI Program.

## **Federal Court Decision**

On 24 May, the Australian Federal Court made a decision about Ausgrid's appeal of

2015-19 electricity charges. Ausgrid won its lengthy appeal on most counts. The Australian Energy Regulator has expressed its strong disappointment with the decision and is considering an appeal. Higher prices for electricity distribution charges for all council's electricity accounts, including street lighting, will eventuate over the coming years if the decision holds. The timing of any revised pricing does not appear likely to be implemented until 2018-19. There will be no backdated charges as a result of this decision but it may have a marked impact on 2019-2024 pricing. SSROC will continue to monitor the impacts of this important case in the context of the current AER pricing review of 2019-2024 pricing.
